MAIN ITEMS OF 98TH MEETING OF BOARD OF MANAGEMENT HELD ON 23-7-2021 AT VETERINARY COLLEGE, SHIVAMOGGA

Item No.2 Review of pay fixation for scientists of IAH&VB, Hebbal, Bangalore

Resolution

The Chairman and Vice Chancellor informed that the extension of UGC scales and other service benefit including pay fitment to Scientists of IAH&VB is having lot of complications. However, the University implemented the same on the basis of Government order if the Government order is modified then only we can implement extending Rs. 8000/- AGP and address the other issues.

Dr.Bhojanaik, Hon'ble Board Member informed that when you extended Rs. 6000/- & 7000/- AGP and why not Rs. 8000/-. He also Informed that in earlier meeting also he urged to equate Rs. 6000/- 7000/- and Rs. 8000/- AGP for all cadres. He also mentioned that the Secretary, Animal Husbandry & Fisheries Department and Hon'ble Board Member informed in last meeting to equate for Rs. 8000/- and send it for ratification to Government. The Chairman & Vice Chancellor informed that since it is financial matter, University cannot implement without the permission of the Government. Hence, in this meeting it has to be discussed in detail and proposal has to be submitted to the Government to issue revised/modified order.

Dr.S.Yathiraj informed that in government order S-1 & S-2 are equated to Assistant Professor but S-1 is equated to Rs. 6000/- S-2 is equated to Rs. 7000/- like wise Rs. 8000/- can be extended based on the service. In this regard University may get permission from the government for which proposal can be submitted to the Government without confirmation of the minutes of the Board.

Dr.K.P.Ramesha Hon'ble Board Member opined that Rs. 7000/- is extended to S-2 Scientists like wise Rs. 8000/- can be extended.

The Chairman informed that to extend Rs. 7000/- AGP, assessment has been done since they were in S-1, S-2 cadre of IAH&VB, Bangalore but to extend Rs. 8000/- assessment was not done. Sri.Bhojanaik, Hon'ble Board Member informed that in the Government order S1 & S2 are equated to Assistant Professor and not mentioned any AGP. Hence, based on the service AGP Rs. 6000/-,7000/- 8000/- AGP can be extended.

The Chairman informed that it is not denying in this regard committee was constituted and report of the same is accepted in 98th Meeting of Board of Management. We have recorded each and every point in the proceedings and we will submit a proposal to Government.

Sri.Bhojainaik Hon'ble Board Member asked that why you have not written Government. The Chairman informed that some of the issues which were not discussed in last meeting that we will discuss now and write it to the Government.

The Principal Secretary, Law Department and Hon'ble Board Member informed that in last Board, the Secretary, Animal Husbandry & Fisheries Department informed take if any modification is required in Government order permission will be given. Hence write a letter to Government without delay in this regard.

The Chairman informed that the proposal in this regard will be sent to Government for issue of modified/revised Government order soon.

On detail discussion and deliberation it was resolved to write a letter to the Government to issue modified Government order to equate S1 and S2 Scientist cadre of IAH&VB to the University cadre of Assistant Professor for Rs. 6000/- Rs. 7000/- and Rs. 8000/- AGP as per UGC/ICAR guidelines. It was also decided to write a letter to Government without confirmation of minutes by including the Scientists whose names are not equated in existing Government order.

Item No.3: Accordal of Permission for recruitment of Backlog teaching posts

Resolution

The Vice Chancellor and the Chairman informed that age and the merit should be the criteria for selection as per 2001 Govt order. He opined that Government order mention only about qualification and not score card.

Dr.K.P.Ramesh, Hon'ble Board Member was of the opinion that based on the qualification has the de merit to the candidates who complete their degree in National Institutes since their OGPA would be lesser than the farm Universities. Hence he urged to consider the score card rather than only age and merit.

Dr.Yathiraj, Hon'ble Board Member informed that the University of Agricultural and Horticultural Sciences, Shivamogga and other Agricultural Universities also notified backlog posts keeping score card as criteria. He urged to consider the ICAR norms

Dr.Dinesh, Hon'ble Board Member also urged to consider the score card as criteria.

Director, Dept of AH&VS and the HOn'ble Board Member was of the opinion that since University follows ICAR norms rather than Dept.of Higher education, the rules specified in ICAR are to be followed.

On detailed discussion and deliberation it was resolved to withdraw earlier notification. Further, it was decided to visit other Farm Universities and re notify the Backlog posts in accordance with the UGC/ICAR guidelines.

Sri.Deepak Doddaiah Hon'ble Board Member informed that University is autonomous body, Board is supreme which can take decision for regularization as per Court order. He also questioned that how 4 staff including Field Assistant were considered previously for regularization as per the court order.

The Chairman replied that these four staff were not regularized, instead they were newly appointed as per the court order.

Director, Department of AH&VS and Hon'ble Member informed that on humanitarian ground it cannot be considered, since as per law DRE/MRE & contractual employees cannot be regularized.

On detailed discussion and deliberation the Board indicated that one more letter would be submitted to Government by mentioning the issue of regularization of only 13 staff as per the court order.
