#### RECOMMENDATIONS OF THE FINANCE COMMITTEE

Construction of administrative building under SCP/TSP at IWVR, Kudige: Dr.K.P.Ramesha, Hon'ble Board Member informed that the details for utilization of Rs. 2.48 crores was furnished upto 5-4-2019 only. The details should be furnished till date. Further he stated that the DD of Rs. 2.48 crores was deposited to Deputy Comptroller account and payment was made to various agencies for which details are not furnished. The Chairman informed that the budget of SCP/TSP is not utilized for other purpose and FD was made for Rs. 2.48 cores. Comptroller informed that as per the direction of the then Registrar, amount was deposited to Deputy Comptroller account and payment was made to various firms. At the same time, General fund for Rs. 2.48 crores of fixed deposit was made. Further, it was withdrawn and at present Rs. 2.48 crores is available in the general fund.

Sri.Bhojyanaik, Hon'ble Board Member informed that it is better to keep fixed deposit in one bank other than in various banks.

Dr.K.P.Ramesha informed that fixed deposit has to be made in National Banks which gives maximum interest. Dr.S.Yathiraj opined that in addition to National banks scheduled bank like Grameena Bank also be considered as our University is to having a mandate of rural orientation and development.

Few members of Board of Management opined to make an Fixed Deposit in a National Bank which pay more interest and some amount in scheduled Bank which are having an trust worthiness. In addition, it was also informed to get a quotation from National Bank and scheduled Bank. Additional Secretary, Finance Department, Govt. of Karnataka informed that Government guidelines-2017 are available to make fixed deposit which are to be followed. On detailed discussion, it was resolved to direct Comptroller, KVAFSU, Bidar to obtain the Government guidelines and make a fixed deposit accordingly.

# MAIN ITEMS OF 94th MEETING OF BOARD OF MANGEMENT HELD ON 5-10-2020

Item No. 1 : Ratification to implementation of UGC scale to Scientists of IAH&V8, Bangalore

Resolution

Dr.S.Yathiraj, Hon'ble Board Member informed that IAH&VB has come to the administrative control of University after extending UGC scale and other benefits from 2014. Hence, KVAFSU guidelines are to be followed with respect to seniority and accordingly, senior faculty has to be placed on independent charge of Director.

The Hon'ble Vice Chancellor informed that Dr.S.M.Byregowda was appointed as per the C&R of IAH&VB. The retirement age as per C&R of IAH&VB was 60 years. After extension of UGC scales and other benefits, University sought clarification from Government with respect to retirement age. The Government clarified that since UGC scales and other benefits are extended as per Government order, in this context University has to take a decision with respect to retirement age. In 95<sup>th</sup> meeting of Board of Management it was unanimously approved to extend retirement age up to 62 years as per KVAFSU guidelines and took a decision to place Dr.S.M.Byregowda on independent charge of Director.

On detail discussion it was resolved to prepare a seniority list and notify the same by giving 21 days duration for filing objections if any. Further it was also decided to place senior faculty as Director of the Institute.

### Item No 2. Appointment of Dr.Senthil Vel under Backlog Recruitment

#### Resolution

Hon ble Board of Management discussed the matter about appointment of Dr.Senthil Vel, Dean (Fisheries), College of Fisheries, Mangalore as Professor (Fisheries Oceanography) vide Notification No. R/KVAFSU/Rectt (T)/BLR(Prof)/2018-19 Dt. 17-10-

2018 under Backlog recruitment. In this regard, Hon'ble member Dr K P Ramesha opined that action has to be initiated against scrutiny committee and selection committee as they have considered the candidate who is not having minimum eligibility criteria with respect to Kannada knowledge,. Further, he stated that candidate himself mentioned that in his application that he is having knowledge of Kannada to speak only.

The Vice Chancellor and Chairman informed that action cannot be taken on committee members at this stage. The probationary period of Dr. Senthil Vel has to be declared subject to outcome of court judgment. He also stated that Dr. Senthil Vel was the only candidate and he was born in Bengaluru and his father was Central Government employee. Hence, he studied in different places of the country.

Sri. Bhojyanaik, Hon'ble member opined that he has to write Kannada exam and pass the exam. Further, Sri. B. Sri Harsha, Hon'ble member informed that he should know Kannada and this information was not brought to the notice of BOM.

On detailed discussion and deliberation, it was resolved to take final decision on his appointment subject to outcome of high court judgment. It was also resolved that his probation can be declared after passing Kannada examination conducted by KPSC.

### Item No 2. Request of Dr. M. Narayanswamy to place him as Dean, VCH

#### Resolution

On detailed discussion and deliberation, Hon'ble Board of Management resolved that at present the request of Dr. M. Narayanswamy to place him as Dean, Veterinary College, Hebbal, Bengaluru cannot be considered due to following reasons.

- The university notified seniority list of teachers irrespective of direct selection or CAS promotion of teachers by way of calling for objections/discrepancies if any and is still upheld till date. The same procedure is also followed in other farm universities of Karnataka and other states in India and in ICAR institutes for preparation of seniority list of teachers.
- The selection procedure like notification, selection cum scrutiny committee for CAS promotion is same as that of direct recruitment.
- As per Karnataka Government Servants (Seniority) Rules, 1957- No. 3 states that, where officers are recruited to a service or a class of post by promotion and by direct recruitment, the officers directly recruited will take precedence over the promoted officers in case where the date of appointment is on the same day.

In this context, the Board of Management directed Registrar to get clarification/information from other farm universities of farm universities of Karnataka and other states, UGC and ICAR. The clarification/ information received from other farm universities, UGC and ICAR, has to be placed in the next BOM meeting for further detailed discussion.
