Construction of administrative building under SCP/TSP at IWVR, Kudige:

Resolution

The Vice Chancellor informed that Social Welfare Department called a meeting on 06-04-2021 to review the utilization of SCP/TSP funds/activities. Further, he informed the Department appreciated the activities of KVAFSU under SCP/TSP and informed to pay back Rs. 2.48 crores to Government and submit a new proposal for grants. He also informed that social welfare department will send a letter for repaying the money. Upon receipt of the letter, Rs. 2.48 crores will be repaid. Dr. K. P. Ramesh informed that the amount earmarked for this purpose is available and that money has to be repaid. At any cost, general/ capital funds of University shall not be utilized for repayment. The Vice Chancellor informed that the same money is available in general fund and it will be repaid to Government.

Dr. K.P.Ramesha informed that as per the information given by Mr. Krishnappa, financial consultant in 2018-19 Audit para recommended for recovery of Rs. 53.15 lakhs which was the loss because of low interest paid for fixed deposit. Mr. Bhojyanaik informed that in 2017-18 & 2018-19, nearly 72 crores was shown under recovery for which committee has to be constituted and action has to be taken to drop the same. The Vice Chancellor informed that FD was made after the competitive bidding only. Smt. Padmavati, FD Secretary informed to follow government guidelines for investing in FD.

<u>Item No 3</u>. Report of the Internal Complaints Committee: Harassment to women employee in the Department of Poultry Science, Veterinary College, Bangalore. Complainant: Dr.Malathi.V. Responded: Dr. Indresh.H.C.

Resolution

The Secretary, Animal Husbandry & Fisheries Department opined through mail stating that the harassment case against Dr.Indresh.H.C needs to be enquired by a bench headed by Retd Judge and with two women members from reputed NGOs who are not connected to the University. As the accused Govt. employee is the president of the University Teachers Association and hence, there is every possibilities that he may influence the enquiry if it is done inside the university. He also informed that the name of retired judge and two of the members from NGOs will be recommended by the office of the Secretary, Dept. of AHF in next 7 days. The Vice Chancellor informed that as per the women harassment Act, the University assigned this case to University level internal complaints committee (ICC). The Committee has completed the enquiry and has submitted the report. Sri.B.Sriharsha informed that someone has seeked information through RTI on Nov 17th, 2020 with respect to projects handled by Dr. Malathi. Dr. Malathi has given women harassment complaint on 8-12-2020. Further, he mentioned that ICC report states that allegations made by the complainant are not proved because majority of witness failed to assert complainants statement.

Dr.S. Yathiraj, Hon'ble Board Member opined that as per the ICC report, board can take any decision on the issue. Smt. Kavitha Umashankar Mishra, Hon'ble Board Member opined that both the faculty members are blaming each other which may create impact on students and their education and it also brings bad name to University. Further, she opined that both the faculty should be advised to drop their individual differences and work together.

On detailed discussion and deliberation, board resolved to keep the issue of taking action based on the ICC report in view of Secretary, AHF opinion.
