<u>Item No. 1</u> Permission for sparing of 26 acres of land for setting up of proposed Khelo India Sports Academy, Dept.of Youth Empowerment & Sports, Govt. of Karnataka in the premises of Veterinary College, Shivamogga

Resolution

On detailed discussion and deliberation the Board unanimously agreed to spare the land of 26 acres at Veterinary College, Shivamogga to Department of Youth Empowerment and Sports, Govt. of Karnataka to take up Khelo India sports Academy as per the request of the Deputy Commissioner, Shivamogga vide letter No. SMG/DC.LND (1)/LG(1)/121/2020-21 (E-58030) Dt. 04-05-2022 with following conditions.

- 1. The land should remain in the name of Registrar, KVAFSU, Bidar.
- An MOU should be signed in this regard between the University and District Administration.
- Alternatively the Government shall allocate 25 to 30 acre grazing land to University for Malnadu Gidda cows
- If commercial activities are conducted in the allotted land the income generated has to be shared in the ratio of 50:50 between the University and District Administration.
- Provision for the students of Veterinary College Shivamogga and KVAFSU for uninterrupted use of sports complex.
- 6. Bio Security issues related to existing livestock farms.

<u>Item No.2</u> Purchasing Ambulance vehicles under the funds provided for the project "Establishment of Ayurveda Centre for its promotion in Veterinary Science at Veterinary College, Shivamogga.

As per the Government order No. ಪಸಂಮೀ 156 ಪಅಸೇ 2021 ಬೆಂಗಳೂರು ದಿನಾಂಕ 11-8-2021, it was informed to establish Ayurveda Research Laboratory at Shivmaogga and to purchase two ambulance out of Rs.1.00 crores budget released and also to purchase similar ambulance vehicles in remaining amount. Director, AH&VB informed that the ambulance vehicles may be retained in the Veterinary Colleges of the University by submitting the proposal to Government. The Board approved the proposal.
