applications in the prescribed proforma are invited from the eligible Non-Resident Indian (NRI)/Overseas Citizen of India (OCI) / Non-Resident Indian Children (NRI's-C) for admission to M.V.Sc.., M.Tech & M.F.Sc., and Doctoral degree programmes at KVAFSU, Bidar for the academic year: 2024-2025.

Candidate who desirous to apply for multiple degree programmes must submit separate applications along with prescribed fee payable in Indian Rupees 10,000/- only, for each of the degree programme.

Eligibility Criteria for admission to Masters' degree programme as per ICAR:

- i. A Bachelor's degree in Veterinary / Dairy / Fisheries science from any Institute / University accredited by VCI, / ICAR New Delhi
- ii. OGPA of 6.00/10.00 or equivalent OGPA / equivalent percentage of marks for general category and 5.50/10.00 or equivalent OGPA / equivalent percentage of marks for SC/ST/Cat-I candidates at Bachelor's degree level for Veterinary and Animal Sciences.
- iii. OGPA of 6.50/10.00 or equivalent OGPA / equivalent percentage of marks for general category and 6.00/10.00 or equivalent OGPA / equivalent percentage of marks for SC/ST/Cat-I candidates at Bachelor's degree level for Dairy and Fisheries Sciences.
- iv. Candidate must have appeared for All India Entrance Examination for Admission to Masters' degree Programme (AIEEA-PG) conducted by NTA-ICAR New Delhi for the academic year 2024-25 and should produce score card (Rank card) in the specified subject at time of admission.

Eligibility Criteria for admission to Doctoral degree programme as per ICAR:

- i. Masters' degree in respective or allied subject from any Institute / University accredited by ICAR, New Delhi.

GUIDELINES AND INSTRUCTIONS FOR ADMISSION TO POST GRADUATE (PG) DEGREE PROGRAMME UNDER NON-RESIDENT INDIAN (NRI)/OVERSEAS CITIZEN OF INDIA (OCI) / NON RESIDENT INDIAN CHILDREN (NRI'S-C) CANDIDATES AT KVAFSU, BIDAR FOR THE ACADEMIC YEAR: 2024-25.

General Information to the Applicants:

- 1. If any of the information provided in the application or documents submitted is found false either during counseling or after admission or at any point of the degree programme admitted, such candidates will be debarred from the admitted course or legal action will be initiated. In such cases the entire amount of Course fee/Institutional economic fee/ other regular fees paid shall be forfeited.
- 2. Economic fees, admission fees, tuition fee, any other fees and charges will be applicable as per instructions issued by the University from time to time.
- 3. Online notification of the candidate's eligibility for offline counseling or the candidates merely attending the offline counseling process shall not confirm their right for admission to the course applied for at KVAFSU, Bidar.
- 4. The decision to fill or not to fill and modalities to fill the seats remaining vacant due to non-availability of eligible candidates by NRI/OCI/NRI's-C shall rest with the university.
- 5. In the event of student discontinuing or cancelling his admission in the middle of degree programme, the student has to pay the processing fees as stipulated by the University for discontinuing or cancelling his admission.
- 6. DISCLAIMER: The statements made and information contained in the Notification / Prospectus is of general nature for the knowledge of the candidate seeking admission to various programmes of the university constituent and affiliated colleges. The information contained herein is believed to be correct at the time of publication/uploading. However, the university reserves the right to make any alteration(s) in the provision(s) contained in the prospectus, at any time without any prior notice, where upon the university will not be responsible for any hardship or expenses incurred by any candidate or any other person on account of such amendments, additions, omissions or errors, no matter how they are caused. The Candidates are advised to visit KVAFSU https://www.kvafsu.edu.in regularly for latest updates regarding admission process and other related information from time to time.
- 7. JURISDICTION: Any dispute/litigation arising out of anything concerned with the university and its activities, including admissions/operation of Academic & Hostel rules shall be subject to the Legal jurisdiction of the Hon'ble High Court of Karnataka, Kalaburgi Bench, Karnataka.
- 8. The successful candidates shall be <u>admitted in the order of preference</u>: Non-Resident Indian (NRI)/Overseas Citizen of India (OCI)/Non-Resident Indian's Children (NRI's-C) respectively. Further, subject to availability of vacant seats if any such seats shall be filled under NRI Sponsored (All India).
- 9. Depending on the availability of seats, the successful candidates may exercise their option for the college at the time of counseling -cum admission. Allocation of the colleges shall be in the order of NRI/OCI/NRI's-C based on the merit.
- 10. The candidates called for counseling must come prepared to pay the Institutional Economic Fee and other regular fees online (RTGS / Net Banking) and must remit such fees at the time admission. In case of failure to remit the prescribed fees at the time admission such candidates shall forfeit their opportunity for admission, and such seat shall be allotted to the next candidate in the merit list.

- 11. All types of Fees must be paid in Indian Rupees only. Foreign currencies either in the form of currency notes/cheques are not acceptable.
- 12. After scrutiny of the applications/successful completion of the counseling process, the University shall issue a 'Provisional Admission Letter' to eligible candidates for the purpose of obtaining a 'Student Visa' from the Indian Consulate/Embassy.
- 13. All International students will require a 'Student VISA' endorsed to Karnataka Veterinary, Animal and Fisheries Sciences University (KVAFSU), Bidar for joining full-time courses.
- 14. Admission of **NRI/OCI/NRI's-C** candidates will be confirmed ONLY after verification of all the relevant original certificates/testimonials, and payment of the required fee and other such requirements, if any, shall be determined by the university from time to time.
- 15. The NRI/OCI/NRI's-C students must abide by the Academic Regulations of KVAFSU, Bidar and the code of conduct as applicable to Indian students enrolled for the degree programme from time -to time.
- 16. For documents other than English, one must submit English translations of all such documents/transcripts, duly attested by the concerned / accredited by the competent authority and duly certified by the Indian Embassy or Consulate.
- 17. Upon arrival in India, every International student must register with the Foreigners Regional Registration Officer (FRRO), Bengaluru within 14 days from the date of first entry into India as per the prescribed applicable procedure and document proof shall be submitted to the University.
- 18. Upon securing provisional admission at KVAFSU, Bidar the concerned International students must submit their Student VISA endorsed to KVAFSU, Bidar within one month of completion of admission formalities, failing which their admission shall stand cancelled.
- 19. International students admitted shall maintain their status of Student VISA throughout the course and students must not change the type of VISA during the study period at KVAFSU, Bidar.
- 20. The International students seeking admission must have a valid student VISA, declared medically fit after examination by the Medical Officer authorized by the Indian Embassy in the home country of the student and they must have full cover of medical insurance for entire period of study/stay in India.

Meaning of Terminologies for admission process at KVAFSU, Bidar:

I. NON-RESIDENT INDIAN:

In the case of the general public, an individual being Indian citizen or person of Indian origin is said to be Non Resident Indian(NRI) in any financial year, if candidate satisfies both the following conditions: Candidate resides in India for less than one hundred and eighty two days (182) during the previous financial year or who stays outside India for employment or for carrying on business or vocation outside India, or who stays outside India for any other purpose indicating his intention to stay outside India for an uncertain period. An Indian Citizen stay in India for less than 365 days during the four preceding previous financial years and less than 60 days in that financial year.

II. NON-RESIDENT INDIAN (NRI) STUDENTS:

- a. Non-Resident Indian students are Indian Nationals studied abroad. They must have had at least 3 (three) years of education in any foreign country during the last 6 (six) years and must have passed the qualifying examination (12th standard or equivalent) from abroad only and in the college/ institutes affiliated to Boards of Secondary Education or Universities located in India.
- b. This includes the Indian students studying in the schools or colleges situated in foreign countries even if they are affiliated to Boards of Secondary Education or Universities located in India, but will not include students studying in those schools or colleges (situated in India)

and affiliated to the Boards of Secondary Education or Universities of the foreign countries.

c. In case an intervening period/gap is involved, a certificate/affidavit from a Class-I Gazetted Officer/Notary Public for the entire intervening period/gap showing the candidate's preoccupation after leaving the Institution last attended shall be produced by such applicants.

III. OCI CARDHOLDERS

The Ministry of Home Affairs vide Notification dated 4th March 2021 specified the rights to which an OCI or POI cardholder shall be entitled under the Citizenship Act, 1955. Clause (4) (ii) of the said Notification reads as under: "(4) parity with Non-Resident Indians in the matter of, (ii) appearing for the all India entrance tests such as National Eligibility cum Entrance Test, Joint Entrance Examination (Mains), Joint Entrance Examination (Advanced) or such other tests to make them eligible for admission only against any Non-Resident Indian seat or any supernumerary seat:

Provided that the OCI/POI cardholder shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

The above Notification provides the following Explanation: "The OCI Cardholder (including a PIO card holder) is a foreign national holding passport of a foreign country and is not a citizen of India." Similarly, the PIO cardholder and foreign nationals shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

IV. NON-RESIDENT INDIAN'S CHILDREN (NRI's-C):

a. Children of NRI parents/guardians are those who have at least one of their parents/guardians residing abroad as an NRI. In case of no parents, the guardian must be an NRI residing abroad and must regard the applicant as his/her ward, as evidenced by an affidavit demonstrating interest in the student's affairs.
