#### Nature of Work:

#### 1. Assisting with Semen Collection and Processing at the Center

The project involves advanced reproductive techniques, including buck semen collection and artificial insemination. Field Workers will assist in the routine collection, evaluation, dilution, and storage of semen. They will also support laboratory procedures and maintenance of records, ensuring quality and biosafety standards are maintained.

#### 2. Conducting Baseline and Post-Intervention Data Collection

Accurate and consistent data collection is crucial for project evaluation. Field Workers will be responsible for gathering baseline data on goat herds before the implementation of interventions and for recording follow-up data post-intervention. This includes animal performance metrics, reproductive parameters, and socioeconomic information from farmers.

#### 3. Monitoring Project Animals in the Field

Regular field visits will be undertaken to monitor animal health, reproductive performance, and management practices. Field Workers will coordinate with beneficiary farmers, ensure compliance with project protocols, and promptly report any deviations or health issues. Their presence in the field will help build trust and strengthen the project's grassroots impact.

#### 4. Assisting in Preparation and Execution of Trainings, Field Demonstrations, and Site Visits

As part of capacity building, the project includes farmer training sessions, practical demonstrations, and exposure visits. Field Workers will play an active role in logistics planning, mobilization of participants, setting up demonstration units, distributing training materials, and recording attendance and feedback.

#### 5. Providing Administrative and Ministerial Support to Investigators

Field Workers will assist the Principal Investigator and Co-Investigators with daily administrative duties such as file maintenance, data entry, communication with stakeholders, coordination with departments, and organizing project documentation. This support will streamline project operations and reporting.
