## **CONDITIONS AND ELIGIBILITY FOR WALK-IN-COUNSELING**

1. Announcement of Vacant Seats in University Website on 07.03.2026, 6 pm onwards.
2. Venue for Walk-in-Selection/Counseling for Admission is at Veterinary College, Bengaluru.
3. Physical reporting date and time of candidates for Walk-in-Admission / Counseling: 10.03.2026. Strictly on or before at 10.00 AM.
4. Candidates coming after 10.00 AM on 10.03.2026 are not eligible for counseling.
5. The candidate should report as per above condition, sign the attendance sheet and while signing the candidate has to submit the Xerox copy of DD amount as applicable based on type of seat (Regular, Self Finance and NRI), Veterinary, Animal, Dairy and Fisheries Sciences.
6. Down loaded copy of application form must be submitted.
7. During registration mandatorily mention whether participating in self finance, NRI seats or not only candidates who have mention willingness in written form only will be considered.
8. **Eligibility for Walk-in-Counseling** : Candidates who have applied for PG / Doctoral Admissions of KVAFSU, Bidar for the academic year 2025-26 and who have not got any seat and have not paid any fees so far are only eligible.
9. **Candidates who are not eligible for Walk-in-Counseling;**
  - (i) Candidates already admitted and have paid fees.
  - (ii) Candidates who have exited counseling process by executing option 4 or choice 'D'.
  - (iii) Candidates who got seat and already paid fees and not reported to college are not eligible.
  - (iv) Candidate who do not bring prescribed DD (Demand Draft) and Original Documents (SSLC/10<sup>th</sup> Marks Card, UG/PG Overall Grade Marks Card / Transcript, PDC / (UG/PG), Caste Certificate / Income Certificate, Special Category (DAP/NCC/SPORTS/NSS/ CES/CAPF/CD (if applicable), Study Certificate (7 years in Karnataka for Karnataka Candidates only), In-Service forwardal letter from competent authority, Xerox copy of Application Form for PG Admission in KVAFSU, Bidar, Score Card - AIEEA (PG/Ph.D.-2025), Rank Card - AIEEA (PG/Ph.D.-2025), Other relevant certificates) .

10. **FEES:** Candidates should bring DD compulsorily in the name of “**Comptroller, KVAFSU, Bidar**”, as per fees applicability, failing which candidates are not allowed to participate in Walk-in-Counseling. A Xerox copy of DD should be submitted to the Registration Counter and original can be submitted only after getting ‘Admission Intimation Letter’ by the Registrar, KVAFSU, Bidar.

**Note:-** 1) The US dollar amount should be paid in rupee equivalent prevailing on the 10.03.2026 as per TT seller rate of SBI Forex card

- 2) If parent income is between 0 to 2.5 lakh then regular fee for all above courses is Rs. 13.450

11. The US Dollar fees to be paid in rupees equivalent on 10.03.2026. The DDs with excess amount or less amount after conversion of US dollar into rupees will not be accepted. The US Dollar rate should be as per SBI FOREX CARD RATES on 10.03.2026. USD to rupees conversion should be as per TT sell rate of SBI FOREX CARD RATES. DDs which are not in accordance with this will not be considered.
12. Candidates who have applied for Self Finance in application form and have not got any seat only are eligible. The candidates who have not applied for Self Finance seats in application form are not eligible for Self Finance seats.
13. Self Finance seat candidates who have not reported to college are not eligible in Walk-in-Counseling for Self Finance seats.
14. Applicants who have applied for Self Finance seats and who have not reported for any seats or not paid fees for any seats are eligible to participate in NRI seat counseling, provided paid Rs. 10,000 application fee and have filled NRI application and brought originals relevant to NRI admission mentioned in NRI application form. The candidates have to bring DD at the time of admission, US Dollar rate TT Sell rates of SBI FOREX CARD and Rates on 10.03.2026. The NRI application can be filled and downloaded from website. Filled Hard copy should be brought to Veterinary College Hebbal, Bengaluru on 10.03.2026 along with document for verification. The NRI application filled application can be down loaded from KVAFSU, Bidar website.
15. Undertaking has to be submitted compulsorily at the Registration Counter on 10.03.2026 at Veterinary College, Bengaluru in stipulated time only.
