- Promotion from Assistant Librarian (Sr. Scale) (Acad.Level-11) to Assistant Librarian (Selection Grade) (Acad.Level-12)
- Promotion from Assistant Librarian (Selection Grade) (Acad.Level-12) to Deputy Librarian (Acad.Level-13A)
- Promotion from Deputy Librarian (Acad.Level-13A) to Deputy Librarian (Acad.Level-14)

A Assistant Librarian/Deputy Librarian must submit three copies of his/her Bio-data along with filled in application. The last date to submit the Bio-data along with application with relevant documents to the concerned Controlling Officer **on or before 22.08.2026.**

A Assistant Librarian/Deputy Librarian who wishes to be considered for promotion under CAS who are eligible (Considering short of service) for promotion in the **next three months (Eligible on or before:21.11.2026)** may also submit his/her application to the University. However, the candidate must ensure he/she fulfils all other requirement as per CAS-2016 guidelines at the time of submitting application. He/she will be considered for promotion from the date on which they fulfils the eligibility conditions.

The Controlling Officers (Deans/Directors) shall verify the correctness of the eligibility of the teacher as per the eligibility prescribed criteria mentioned in the notification ref No (1) and forward to this office by **05.09.2026.**
