2. Fresh post graduates with a NET qualification in the relevant subject conducted by ICAR/UGC/VCI are also eligible.
3. Teachers in the position of Assistant Professor, Associate Professor or Professor in the relevant subject retired from service from recognized Veterinary College or Veterinary / Farm University can also appear. However, the candidate must be physically fit and should not be older than 70 years.

Honorarium payment in consolidated basis:

Rs. 50,000/- PM (Rupees Fifty thousand only) (No other allowance admissible)

Terms and Conditions:

1. The Candidates should appear for interview along with required original documents
2. NET cleared candidate are preferable.
3. The Qualifications prescribed by University for the post of Assistant Professor shall be followed .

4. Candidates should possess a valid KVC/VCI registration
5. Candidates should produce all the original documents viz.: Degree certificate, Proof for date of birth, Experience, Case certificate, etc., before the committee at the time of interview.
6. No TA/DA will be paid to the candidate appearing for the interview.
