Instructions to contributors

I) Scope of the Journal

“**Frontier Journal of Veterinary and Animal Sciences**” is published by Karnataka Veterinary, Animal Sciences University, Bidar twice in a year. The journal is intended to publish review articles and original research papers on all aspects of Veterinary, Animal, Dairy and Fisheries Sciences that have neither been published nor being considered for publication elsewhere. The Editorial Committee has right to accept or reject a paper based on scientific merits as judged by the referees and Editorial Board. It is mandatory that each and every author should be a member for the journal.

II) Manuscript preparation and submission

1. Manuscript, in English should be typed in A4 size paper in double space on one side of the page not exceeding 10, 15 and 8 pages (inclusive of tables, illustration and references) for review article, research article and research note/ case reports respectively.
2. The cover page of the manuscript should carry the title of the research paper, the names of the authors, their affiliation, complete postal address along with their email ID. The title of the research paper should be typed with first letter of every word in capital. The name of the authors should be written with first letter of the name and initials in capital. If the paper forms part of post graduate and doctoral thesis, it should be mentioned with an asterisk to the title of the paper.
3. Authors are required to submit both blinded and unblinded versions of the article along with duly signed author declaration form (download from www.kvafsu.edu.in/fjvas). The unblinded copy should include author name, author institution details, author contact details, acknowledgements and the title page. The blinded copy shouldn't contain author name, author institution details, author contact details, acknowledgements and title page with only the title of the article.
4. The manuscript should have the title followed by the abstract not more than 300 words for the review and research articles and 150 words for case reports and short communications. Mention maximum of five key words for review and research articles and three words for case reports and short communications.

5. Research article should have brief introduction, material and methods, results and discussion, references and tables (if any) with headings. All headings should be typed in capital in the centre. Case reports should have history and clinical signs, diagnosis and treatment and, discussion and conclusion. Research note should have brief introduction, material and methods, results and discussion in a single section without headings along with references and tables (if any not more than two). References should be cited in the text by the names of the authors followed by the year of publication.
6. References should be listed alphabetically as indicated below,

The authors name should be followed by the initials (author names should be written in lower case with initials and first letter of the author in capital), the year of publication in parenthesis, title in lower case, journal name in approved abbreviations in italic, volume number in bold letter and issue number in parenthesis: page numbers. While citing from books and other publications it should include, author name, year of publication, title, edition, publisher's name, place of publication, pages cited. While citing from thesis, it should include, author name, year, title, M.V.Sc./M.Sc./Ph.D thesis, University and place. Visit www.kvafsu.edu.in/fjvas for writing references.

7. Tables and illustrations if any should be on separate sheets, numbered consecutively in Arabic numerals (Table 1/ Figure 1) and should have short descriptive heading for tables and legends for illustrations in sentence case. Units, symbols and abbreviations used in table should confirm to the international system. Photographs and photomicrographs should be printed on glossy paper with good contrast. Magnification for photomicrographs should be indicated.
8. **Processing charges:** Rs 500 per article for Indian and US \$50 for foreign articles must be sent along with the article in the form of Demand Draft or International cheque drawn in favour of Chief Editor, FJVAS, payable at Bidar. Payment of processing fee will not ensure publication of the article. Printing of colour photos and reprints costs extra charge.
9.
